












Compulsory Motor Insurance is required by law. Vehicle owners must insure their vehicles. Violation is punishable by a fine of up to 10,000 baht.



Juristic Person

Company:

 Certificate of Registration (issued by the registrar within the past 6 months), stamped with the company seal, and a copy of the authorized signatory's ID card.

In case of authorization:

 Power of Attorney (signed by the authorized signatory of the juristic person and the authorized representative), stamped with the company seal (if any), with copies of the ID cards for both the authorized signatory and the authorized representative.

Partnership:

 Partnership Registration Certificate (issued by the registrar within the past 6 months), stamped with the company seal, and a copy of the authorized signatory's ID card.

In case of authorization:

• Power of Attorney (signed by the authorized signatory of the juristic person and the authorized representative), stamped with the company seal (if any), with copies of the ID cards for both the authorized signatory and the authorized representative.

Government agencies, state-owned enterprises, or other government entities that are juristic persons.

• Letter of intent to conduct a transaction or appointment letter, and a copy of the ID card of the authorized signatory.

In case of authorization:

• Power of Attorney (signed by the authorized signatory and the authorized representative), stamped with the company seal (if any), and copies of the ID cards of both the authorized signatory and the authorized representative.

Cooperatives, foundations, associations, clubs, temples, mosques, shrines, and other juristic persons

• Letter of intent to conduct a transaction or a registration certificate from the relevant authority, or an appointment letter, and a copy of the ID card of the authorized signatory.

In case of authorization:

• Power of Attorney (signed by the authorized signatory and the authorized representative), stamped with the company seal (if any), and copies of the ID cards of both the authorized signatory and the authorized representative.
